

Raw Water Storage Tank Rebate Program Terms and Conditions

Terms and Conditions

- Funding is limited, and submitting a rebate application does not guarantee you will receive a rebate.
- Rebates are issued on a first-come, first-served basis until funding is depleted.
- Limited to NID raw water customers receiving a minimum of ¼ miner inch of irrigation water per year. Customers account must be active and in good standing.
- Customers with no storage may be given priority over those with existing tank or pond storage.
- Limit of one raw water storage tank rebate per account and/or parcel served by the Nevada Irrigation
 District.
- Rebate amount will vary based on size of storage tank purchased and installed
 - 500 gallon tank will receive a rebate of \$150.00 or the actual cost, whichever is less.
 - 600-1,500 gallon tank will receive a rebate of \$300.00 or the actual cost, whichever is less.
 - 1,600 gallon or larger tank will receive a rebate of \$500.00 or the actual cost, whichever is less.
- Rebate amount does not include cost of tax, shipping, or installation.
- The program is not retroactive. Projects underway or completed prior to receipt of the approval letter or email are ineligible.
- Purchase and installation are required within 90 days of approval of the step 1 application. Approved
 applications will be void after 90 days of receipt. Applicant must fill out new application with no
 guarantee of available funds.
- Installation is the sole responsibility of the customer. NID staff will not give customer technical assistance to selection, placement or design and installation of the tank.
- Applicant must submit a copy of the sales receipt and proof of installation prior to receiving rebate

Terms and Conditions (continued)

- Proof of installation is required and will be subject to on-site inspection.
- The Nevada Irrigation District makes no representation or warranty relating to storage tanks, including
 any hazardous substances that may be contained in the product.
- Applicant waives and releases NID and its contractors or agents from all claims and causes of action arising out of the installation and use of devises pursuant to the Raw Water Storage Tank Rebate Program.
- Final Rebate will not be issued until proof of installation is returned to NID and has been reviewed and approved.
- Rebate will be issued as a bill credit on the customers' account.

Additional Responsibilities of Customer/Applicant:

Nevada Irrigation District enforces only the terms and conditions of this agreement. The applicant is solely responsible for complying with any and all laws, regulation, policies, CC&Rs (Covenants, conditions, and restrictions) that may apply, and for any and all liabilities arising out of a tank installation project. Applicants must comply with local permitting requirements, and with all state and local laws relating to landscaping or related projects
