SUBJECT: Purchase of Vac-Con Hydro Excavator

MAINTENANCE

RECOMMENDATION: Approve the purchase of the Vac-Con Hydro Excavator from MME from Sacramento in the amount of \$413,793.36 and authorize the General Manager to sign the necessary documents.

BACKGROUND: This purchase price was submitted by MME using the NJPA -National Joint Powers Alliance process which is similar to the CMAS (California Multiple Award Schedules) that NID uses to purchase work trucks. This is a standard bidding process utilized by public agencies in which prices are negotiated through the Alliance and this cooperative purchasing group guarantees the lowest pricing for the hydro excavator truck and the components.

Even though the price for this hydro excavator is large, it represents a cost savings through greater work efficiencies by NID personnel. The Maintenance Department rented a hydro excavator for several weeks to determine if the machine would be useful to NID in our day to day operations.

The rented hydro excavator was used by the Construction crew for pot holing on the Penn Valley pipeline project. During a construction project it is necessary to pot hole in front of the excavation to locate the other utilities that might be in conflict with the pipeline installation. A typical pot hole using a backhoe takes approximately 30 minutes and requires a minimum hole size of 3 ft by 3 ft. Using the hydro excavator, the Construction crew was able to locate utilities in approximately 5 minutes with a hole size of 1 ft by 1 ft. Not only is the time requirement drastically reduced but the amount of asphalt repair is much less.

The rented hydro excavator was also used by the Canal Maintenance crew to clean out culverts and the Operations Department at the North Auburn treatment plant to clean out the drain and washout basin. These additional uses are something that we have not been able to do with our conventional equipment and this hydro excavator will prove to be useful for all departments throughout the District.

**BUDGETARY IMPACT**: A budget amendment is included in the staff report. This item was not directly budgeted in the 2017 budget. The funds to purchase this item has been accounted for by the postponement of budgeted equipment purchases (52904) through the realization of savings on completed capital projects (52915) and savings from lower gas prices (52501).
