SUBJECT: Alta Sierra Reservoir Replacement Project (Project #6971) (Consent)

ENGINEERING

RECOMMENDATION:

Adopt a resolution approving an amendment of the Fund 15 Capital Budget to include the Alta Sierra Reservoir Replacement Project (Project No. 6971) in the amount of \$272,710.

BACKGROUND:

The Alta Sierra Reservoir Replacement Project (Project No. 6971) replaced the existing Hypalon-covered and lined reservoir with a 3-million-gallon prestressed concrete tank. This tank is part of the treated water system and serves as storage for Alta Sierra and Brewer BEP service areas.

The project has been completed and the final pay request from Gateway Pacific Contractors, Inc. (Gateway) has been received by the District. At the time the Board approved the 2024 budget, staff did not yet know what the final pay request amount would be and therefore did not include this project in the budget. Staff had anticipated bringing a budget amendment to the Board once the final amount was determined. This amendment does not increase the overall contract amount that the Board approved with Gateway.

BUDGETARY IMPACT:

This action requires an amendment of the Fund 15 Water Capital Budget to include the Alta Sierra Reservoir Replacement Project (Project No. 6971) in the amount of \$272,710.

This amendment does not increase the overall contract amount with Gateway.

Approval of the proposed amendment would increase the total Water Capital Fund 15 Budget by \$272,710 to \$9,304,106, with a projected ending spendable fund balance of \$19,156,249 at year-end.
