SUBJECT: FY2023 Mid-Year Budget Amendment

RECOMMENDATION:

Adopt a resolution approving the Mid-Year Budget Amendment.

BACKGROUND:

The Fiscal Year (FY) 2023 budget was adopted by the Nevada Irrigation Board of Directors on December 14, 2022. Each quarter thereafter, the budget is reviewed for accuracy and performance, and adjusted internally or amended by the Board as needed.

Staff have prepared the quarter ending June 30, 2023, Budget Reports for Quarter 2 (Q2), or mid-year and as part of that process have identified items within the budget requiring adjustment.

The annual budget is a living document that must be reviewed and updated for accuracy periodically. The proposed mid-year amendment improves the accuracy of this year's Budget and financial plan.

REPORT SUMMARY:

The total proposed amendment to inflows is \$527,161, including revenue increases of \$53,583 and transfers in totaling \$473,578.
