SUBJECT: Final Asphalt Paving for Phase 1 of the Lidster Avenue and Cypress Hill Drive Unit 1 Waterline Replacement Project (FATR #2071)

MAINTENANCE

RECOMMENDATION:

Award a Construction Contract to JB-TC Ventures, Inc., dba JB Bostick Company, for the final asphalt paving of Phase 1 of the Lidster Avenue and Cypress Hill Drive Unit 1 Waterline Replacement Project, in the amount of \$130,392.00, and authorize the Interim General Manager to execute the necessary documents.

BACKGROUND:

As part of Nevada Irrigation District's (NID or District) efforts to maintain a high standard of water quality and reliability, the District maintains the Pipeline Replacement Program to replace aged and deteriorated water distribution infrastructure identified as causing frequent interruptions to the water service of District customers. The Lidster Avenue and Cypress Hill Drive area was identified as one of the Program's project locations for 2020 because of the increased frequency of leaks and maintenance issues occurring in the area.

The Lidster Avenue and Cypress Hill Drive Unit 1 Waterline Replacement Project includes the installation of approximately 7,200 feet of water main and service lines, fire hydrant laterals and new dry barrel fire hydrants by NID crews. The overall project area includes all or portions of Lidster Avenue, Cypress Hill Drive, Arcadia Drive, Barby Drive, Huntington Court and Arden Court in Grass Valley, California.

The resulting trench paving effort will include the installation of final asphalt patches over both water main and service line trenches, in accordance with the conditions set forth in the Encroachment Permit issued by the City of Grass Valley for this Project.

The final asphalt paving for Phase 1 of the Project will occur on all of Lidster Avenue and portions of Cypress Hill Drive and Arcadia Drive, as highlighted on the attached Project Map.

District Staff solicited bids from seven area paving contractors. Four contractors attended the mandatory pre-bid site tour/meeting on August 6, 2020. Three of the four contractors submitted quotes on August 13, 2020. JB-TC Ventures, Inc., dba JB Bostick Company, provided the lowest quote at \$130,392.00.

Award of the Construction Contract is in alignment with Goal Numbers 1 and 2 of the District's Strategic Plan, as it supports reliability of District treated water infrastructure and maintains compliance with local regulations.

BUDGETARY IMPACT:

The funds for this Project will come from the Pipeline Replacement Account (10151-52907) with a current available balance of \$738,649.00. The contract amount is \$130,392.00. If approved, the balance remaining in the Pipeline Replacement Account will be \$608,257.00.
