RECOMMENDATION:

Adopt the following two resolutions to amend and supersede Resolution No. 2023-34 and Resolution No. 2023-35; authorize the acceptance and execution of grant funds; and authorize the General Manager to execute the appropriate documents:

- Resolution 1: Quagga and Zebra Mussel Infestation Prevention Grant Program Tier 2
 Implementation Project Scotts Flat and Rollins, in the amount of \$27,541.96
- Resolution 2: Quagga and Zebra Mussel Infestation Prevention Grant Program Tier 2
 Implementation Project Deer Creek Diversion, in the amount of \$10,605.05

BACKGROUND:

On August 23rd, 2023, Resolutions No. 2023-34 and No. 2023-35 were passed and adopted authorizing the acceptance and executions of two grants for the implementation of state-required monitoring for invasive Quagga and Zebra Mussels at Rollins, Scotts Flat, Deer Creek Diversion, and Combie Reservoirs. However, the State of California, Department of Parks and Recreation Division of Boating and Waterways' (DBW), the administrator of the grants, only offered NID partial funding of the total amount requested, and as such the DBW requests that we adopt new resolutions that reflect the partial award amounts.

The grant covering monitoring efforts at Scotts Flat and Rollins Reservoirs has been amended from \$49,541.96 to \$27,541.96. The grant covering monitoring efforts at Combie and Deer Creek Diversion Reservoirs has been amended to remove mention of Combie (as no activities were funded at the Reservoir) and adjust the award amount from \$32,905.56 to \$10,605.05.

BUDGETARY IMPACT:

If awarded and accepted, expenditures and revenues will be part of a FY 2023 and 2024 Budget Amendment as needed.

Funding amounts requested:

Rollins and Scotts Flat Project:

\$49,541.96 requested, \$27,541.96 offered.

Combie and Deer Creek Diversion Project:

\$32,905.56 requested, \$10,605.05 offered (No funding offered for Lake Combie).

Total Project Cost including in-kind:

Rollins and Scotts Flat Project: \$27,541.96 (Grant does not require any in-kind funding).

Deer Creek Diversion Project: \$10,605.05 (Grant does not require any in-kind funding).

Schedule: The proposed projects would be funded over a 2-year period. If selected for grant awards, grant agreement execution should be complete before the end of 2023. Project implementation for both grants will occur concurrently from December 2023 through December 2025.
